Mission Statement

The mission of the Oceana Land Use Conformity Committee is to make recommendations to City Council and the Virginia Beach Development Authority (VBDA) on matters relating to reducing the amount of pre-existing nonconforming development, under Section 1804 of the City Zoning Ordinance, in APZ-1/Clear Zone Use and Acquisition Plan, the Comprehensive Plan, the Final Hampton Roads Joint Land Use Study (JLUS), and with good zoning practices that do not adversely affect established residential neighborhoods.

Accomplishment of Goals and Objectives

The goal of OLUCC is to make recommendations to City Council, Planning Commission, and Virginia Beach Development Authority regarding:

1. Agreements and transactions that further the purposes for which the Committee was created.

- 2. Zoning and other land use ordinances, including the advisability of adopting new or amended ordinances.
- 3. Discretionary zoning applications, such as rezoning and conditional use permits.
- 4. Ordinances imposing fees or taxes, including the advisability of adopting new or amended ordinances; and
- 5. Staffing and resources necessary, or appropriate, to assist the committee in the exercise of its duties.

Over the past fiscal year, its appointed volunteers and its liaisons have not been presented with a reason to hold any additional meetings except the meeting in August 2024 to approve and adopt the annual report to City Council.

The Oceana Land Use Conformity Committee respectfully requests the continued support of the Virginia Beach City Council through City Council direction and with the assistance of the City's Development Authority in accomplishing the rollback of nonconforming property uses to conforming property uses.
