

A RESOLUTION TO AWARD FUNDS RECEIVED
BY THE CITY UNDER THE CARES ACT
TO QUALIFYING BUSINESSES

WHEREAS, the City Manager has declared a local emergency during the current COVID-19 Pandemic (the "Local Emergency");

WHEREAS, the limitations on gatherings of persons have brought certain portions of the local economy to a halt, which has resulted in numerous layoffs and financial hardships throughout the business community;

WHEREAS, the statutory authority of the Authority includes as a public purpose the promotion and encouragement of economic development;

WHEREAS, the Authority is authorized by statute to make grants to businesses in furtherance of its mission;

WHEREAS, on July 7, 2020, the City Council of the City of Virginia Beach (the "Council") accepted an appropriation of federal funds (via the Commonwealth) under the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act");

WHEREAS, City Council has made a portion of the monies received under the CARES Act (the "CARES Act Funds") available to the Authority for distribution to businesses consistent with the mandates of the CARES Act and policy of the Authority adopted August 18, 2020 (collectively the "CARES Act Guidelines");

WHEREAS, on October 20, 2020, the Authority adopted a resolution approving the first round of awards of the CARES Act Funds;

WHEREAS, the Authority has accepted and reviewed additional applications under the CARES Act Guidelines and desires to approve the second round of awards to the recipients as set forth on Exhibit A, attached hereto and made a part hereof (each an "Award" and collectively, the "Awards"); and

WHEREAS, the Authority is of the opinion that the Awards as shown on Exhibit A are consistent with the CARES Act Guidelines and will further the purposes of the City, Authority and the CARES Act.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY OF VIRGINIA BEACH DEVELOPMENT AUTHORITY THAT:

1. The Authority makes the following findings with respect to each Award:
 - i. That each recipient as shown on Exhibit A qualifies under the CARES Act Guidelines for the receipt of CARES Act Funds.

ii. That the expenditure of such funds will only incidentally enure to private interests, if at all;

iii. That the proposed provision of funds for each Award is in furtherance of the purposes for which the Authority was created; and

iv. That the continued operations of each business receiving an Award will be beneficial to the local economy after the expiration of the Local Emergency.

2. That based on the above findings, the Authority hereby approves the Awards under the CARES Act Guidelines to the recipients and in the amounts as shown on Exhibit A.

3. That disbursement of funds by the Authority shall be at the discretion of the Director of the Department of Economic Development of the City of Virginia Beach or his designee, who shall be authorized to require appropriate verification as to qualifying expenditures and who shall require a recapture agreement where deemed appropriate by the Director.

4. The Chair or Vice Chair is authorized to execute any documents necessary to implement the Awards, so long as such documents are acceptable to the Chair or Vice Chair and in a form deemed satisfactory by the City Attorney.
